21.05.2019	<p><b>Whereas</b>, counting of votes in connection with the General Elections to the Lok Sabha, 2019, for 6-Balurghat Parliamentary Constituency is scheduled to be held on 23<sup>rd</sup> May, 2019 from 8.00 am. onwards at Balurghat College, Balurghat, Dakshin Dinajpur, And</p> <p><b>Whereas</b>, the Election Commission of India has directed the District Magistrate &amp; District Election Officer to take necessary measures for smooth and peaceful conduct of the counting process, And</p> <p><b>Whereas</b>, there is every likelihood of gathering of supporters of every candidates surrounding the counting venue at around 6.00 am. onwards, And</p> <p><b>Whereas</b>, disturbance of peace and public tranquility in the surrounding areas of the counting venue during the counting process is apprehended ;</p> <p><b>Now</b>, therefore, after careful consideration of the matter, I, Smt. Deepap Priya P, IAS, District Magistrate &amp; District Election Officer, Dakshin Dinajpur, am of the opinion that there is sufficient ground for proceeding under section 144 Cr.P.C., 1973 and immediate prevention is desirable and as there is no sufficient time for issuing notice individually, hence, in exercise of the power conferred upon me u/s 144 Cr.P.C., 1973 do hereby prohibit public in general gathering of five or more people except counting officials and counting agents and supporting staff relating to counting and entry of unauthorized persons and carrying of licensed fire arms and other lethal weapons within a periphery of 100 metres from outer boundary of the counting premises in order to prevent a disturbance of the public tranquility or a riot or affray.</p> <p>This order will take effect from 6.00 am. on 23.05.2019 and will remain in force until 6.00 pm. on 24.05.2019 or till the counting process is over, whichever is later.</p> <p>GIVEN UNDER MY HAND, SIGNATURE AND SEAL ON THIS DAY OF 21.05.2019</p> <p style="text-align: right;"> District Magistrate Dakshin Dinajpur</p>
