

<p>20.04.2019</p> <p>Dictated and corrected by me</p> <p></p> <p>District Magistrate Dakshin Dinajpur</p>	<p>WHEREAS, with the Press Notification of the Election Commission of India, the process of General Election, 2019 to all the Parliamentary Constituencies in this district has been started</p> <p>And</p> <p>WHEREAS, the Election is to be conducted in each Polling Station amidst peace and tranquility.</p> <p>And</p> <p>WHEREAS, there is sufficient reason to apprehend and urgent measure are called upon for preventing any tension, intimidation or disturbance to and among the contending parties in particular and people in general and there may crop up any dangerous approach of anyone which may lead to breach of peace and trainquility causing serious threat to the peaceful conduct of the election process itself and to the life and properties of the people in general:</p> <p>And</p> <p>WHEREAS, I ,Smt. Deepap Priya P, IAS, District Magistrate , Dakshin Dinajpur, is of the opinion that there is sufficient ground to proceed U/S 144 Cr.P.C. at all polling stations of the district and to prevent any breach of peace and trainquility and danger to human life do hereby promulgate this order upon the holders of licensed arms prohibiting them from carrying any sorts of Arms, Ammunitions and Explosives with his person or in his custody during the whole period so long the Model Code of Conduct is prevailing.</p> <p>And order is also issued that</p> <p>The ambit of this order does not include police, central forces and other security personnel on duly authorized by the Govt. to carry Arms/Explosives for discharging their duties.</p> <p>Order is also issued that</p> <p>This order comes with an immediate effect and shall remain enforce till issuance of further order to that effect or withdrawal of Model Code of Conduct whichever is earlier.</p> <p>GIVEN UNDER MY HAND, SIGNATURE AND SEAL ON THIS DAY OF 20.04.2019</p> <p></p> <p>District Magistrate Dakshin Dinajpur</p>


