


Advertisement for engagement of part time Homeopathic medical Officer (AYUSH) under NRHM

| 3. | Age | Not more than 50 years on 1 st January, 2015 upper age limit is relax able for 5 years for SC/ST candidates. |
| 4. | Honorarium | The part time Homeopathic Medical Officer will be given honorarium on daily basis subject to maximum 20 days in a months and other terms & conditions in accordance with the order of West Bengal Panchayat and Rural Department. |
| 5. | Last Date and time of receiving Application by Hand or by post | 13/02/2014 upto 4.30 PM at concern Block Development Office. |
| 6. | Date of Viva-Voice test | 21/02/2014 at 11.00 AM |

General instruction / Guidelines for the candidates:

- 1) Application in prescribed format along with attested copy of the mark sheet and other certificate along with the age proof and permanent residential proof will have to be submitted within due period to appropriate authority.
- 2) Application duly filled up in the prescribe proforma in the sealed envelope along with the self addressed envelope (10.2X4.5) with postage of Rs. 5/- affix on it may be deposited by Hand or by post to the office of the Block Development Officer. The receiving officer of the Block Office will issue the receipt in prescribed proforma attached with the application from to the candidate and the candidate will collect the receipt by his/her effort. The receiving officer will make entry in the register as per guideline memo No. 65/SPHC/2M-2/09 dated 22/02/2010.
- 3) A) Applicants within the concern Gram Panchayat will get preference.
B) if no candidate is available from Gram Panchayat then candidate from the Block area shall be consider and selection will be made observing procedure as per guideline.
C) if no candidate is available in the in Block area. Candidate from the Sub-Division will be considered following the same procedure. Candidates from other area of the District will only be considered in case of non-availability of applicant in the Sub-Division area.


