Terms & Condition

Ref: Auction Notice No. 258/PS Dated 26/02/2013 regarding Auction of standing trees by the side of Gopalpur to Chingishpur Road to be held on 08.03.2013

1. This open auction on standing trees is open to all. All intending party/parties may participate on this auction fulfilling some official terms & conditions.
2. The successful bidder will have to deposit total auction value within 3(Three) working days from the date of auction, failing to which the order may get cancelled and the earnest money may be forfeited.
3. In case of failure of deposit of auction value within 3(three) days, the auctioned trees will be offered to second highest bidder,
4. Earnest money deposited of the highest three auctioneer will be released after completion of the cutting and clearing work.
5. The felling and clearing of trees to be completed within 7(seven) days from the date of issue of cutting order from the undersigned.
6. Selected Agency will be liable for felling, stacking and removal logs and woods on its own risk, no responsibility will be taken in this regards by the authority.
7. Felling of trees is strictly limited to the plantations as stated in the open auction notice.
8. (a) Only marked trees for auction are to be cut down by the purchaser after due permission.
(b) This department/office or any officer of this department will not be held responsible for any damage or loss of trees or logs due to fire natural calamities or otherwise after the date of auction.
(c) Claim arising out of shortage of trees of clear felling logs will not be entertained. The condition and quantity of the timber in the trees offered for sales are not guaranteed and the undersigned will not, therefore, accept any liability for any defects in the trees. The undersigned does not either guarantee the correctness of the species as stated in the schedule nor does guarantee the accuracy of the measurement and no claim in respect of short measurement or of alleged discrepancies of such a nature will be entertained. The undersigned will also not entertain any claim on grounds of trees being situated in difficult position. 17. This notice is published in the interest of the public service as well as for the sake of common people.


