Application are invited from the citizens of India having requisite eligibility laid down in the table below, for engagement to post of part time Homoeopathic Medical Officer (AYUSH) under NRHM for the Gram Panchayat level dispensary of the Banshihari Block in Dakshin Dinajpur district.

1	Name of the post	Homoeopathic Medical Officer (part time)
2	Vacancy	a) One post in Ellahabad Gram Panchayat. b) One post in Mahabari Gram Panchayat.
3	Qualification	Post Graduate Degree (MD). A Graduate (BHMS) or a Diploma (DMS/DHMS) in Homoeopathy from an institution recognized by Central Council of Homoeopathy and must be registered with State or Central Council of Homoeopathy
4	Age	Not more than 50 years on the 1 st January, 2014. Upper age limit is relaxable for 5 years for SC/ST candidates and 3 years for the OBC candidates.
5	Honorarium	The part time Homoeopathic Medical Officer will be given honorarium on daily basis. The rate is at present Rs. Five Hundred & Fifty (550/-) only per day with maximum upto twenty days (20) in a month.
6	Last date and time of receiving Application by hand or by post	21/02/2014 upto 5.30 PM at Banshihari Block Development Office.
7	Date of viva – voce test (If required)	27/02/2014 at 12 noon at BDO's chamber

General instructions / Guidelines for the candidates:

1. Application in prescribed format along with attested copy of the mark sheet and other certificates along with the age proof and permanent residential proof will have to be submitted within due period to appropriate authority.
2. Application duly filled up in the prescribed proforma in the sealed envelope along with the self addressed envelope (10.5x4.5) with postage of Rs. 5/- affix on it may be deposited by hand or by post to the office of Block Development Officer, Banshihari The receiving officer of the Block Office will issue the receipt in prescribed proforma attached with the application form to the candidate and the candidate will collect the receipt by his/her effort.
3. One candidate can apply for more than one G.P. level dispensary. The name of the post will have to be clearly mentioned on sealed envelope.
4. A) Applicants within the concern Gram Panchayat will get preference.
B) If no candidate is available from Gram Panchayat then candidates from the Block area shall be considered and selection will be made observing procedure as per guideline.
C) If no candidate is available in the Block area, candidates from the Sub-Division will be considered following the same procedure. Candidates from other area of the district will only be considered in case of non-availability of applicant in the Sub- Division area.
