In terms of Notification vide No. 339/2016/DLSA-DD, dated: 01.03.2016, Recruitment Committee, DLSA, Dakshin Dinajpur had invited application for filling up one post of **Stenographer in the office of District Legal Services Authority, Dakshin Dinajpur** and one post of **LD Assistant as Secretary-cum-Accountant in the office of Sub-Divisional Legal Services Committee (SDLSC), Gangarampur at Buniadpur.**
