In partial modification of this office notice memo no. 218/MGNREGA, dated:- 10.10.2017, the following changes are hereby made in respect of "Educational Qualification" & "Residence" as per memo no.- 5221-RD/O/NREGA/18S-03/09(Pt-II), dated:- 18/10/2017 of the Commissioner, P& RD Department.

1. Educational Qualification:-

(A) The candidate should have passed Higher Secondary Examination in **Pure Science Stream/ Vocational Stream** with at least 55% marks in **Physics and Mathematics** as compulsory subject. The candidate who passed the said examination from any recognized Board of the state of West Bengal will be preferred.

(B) The candidate must have at least **six months** training certificate on computer application from any recognized institute.

2) Residence: The candidate should be the resident and voter of Tapan block. The stipulation of residence within Hazratpur G.P is thus modified. **So the candidate selected in terms of merit will be engaged by the BDO & Programme Officer, MGNREGA, Tapan Block. Candidates belong to beyond the Tapan Development Block Jurisdiction area cannot apply.**
