As per the Advertisement Notice No. 6820, dt. 23/02/2016 of the undersigned, the selection test of purely contractual engagement of Data Entry Operator under CMDMP of Tapan Development Block had been cancelled on 01/03/2016 due to some unavoidable circumstances now the same selection test will be held on 19/08/2017 (Saturday) after partial modification of the selection procedure mentioned by the Advertisement Notice (No.6820, dt. 23/02/2016) is as follows:

Recruitment will be made on the basis of Written Test, Computer Test and Interview/ VIVA VOCE to be conducted by the Block Level Selection Committee, Tapan Development Block, Dakshin Dinajpur. Shortlisted Candidates on the basis of marks obtained in the written test and computer test will be called for interview in the same day. Qualifying Marks for the candidates called for interview will be decided by the Block Level Selection Committee on engagement of DEO, (CMDMP), under Tapan Dev. Block.

- 1) Written test will carry 60 marks, duration 60 minutes (1(one) mark will be deducted for each 3(three) wrong answer) comprising of MCQ type questions related to General Knowledge & Current Affairs, Arithmetic & Reasoning, Basic English & Bengali Grammer and Computer Knowledge.
- 2) Computer Test: Full Marks-20
- 3) VIVA VOCE: Full Marks-20
