ORDER

No. 03 /J.M./L.O.Cell,

Whereas, the Panchayat General Elections, 2018 for the District of Dakshin Dinajpur has been declared vide no. 517-SEC/1E-88/2017(Pt-II) dated 2nd April, 2018 by the West Bengal State Election Commission; And

Whereas, it is expedient to impose restriction regarding holding of licensed arms; And

Whereas, it is essential to conduct the ensuing Panchayat General Elections peacefully and in free & fair manner in the entire area of the district of Dakshin Dinajpur; And


Whereas, the West Bengal State Election Commission has requested the District Magistrate to consider, asking the license holders of arms to deposit their arms till one week after the declaration of results; And

Whereas, there is reasonable apprehension that fire-arms may get misused or license holders may get involved in any law and order problem or in threatening the other persons,

Now, therefore, after careful consideration of the matter I, Shri Sharad Kumar Dwivedi, I.A.S., District Panchayat Election Officer & District Magistrate, Dakshin Dinajpur, in exercise of the power conferred upon me u/s 17(3)(b) of the Arms Act, 1959 suspend all the licenses of arms of this district till one week after the declaration of results of the Panchayat General Elections, 2018 and direct as per section 21(1) of the said act that all the licensee of arms of this district should mandatorily deposit the arms with the respective police stations/ license arms dealer within **20.04.2018** and the same will remain deposited there till one week after the declaration of results, i.e., till **15.05.2018**.

Further, the arm licensee who wants exemption from deposition of their arms shall apply to the undersigned through concerned IC/OC of the Police Station. Inspector-in-charge/Officer-in-charge of the police stations are directed to send the applications to the District Panchayat Election Officer & District Magistrate, Dakshin Dinajpur, with antecedent report and specific comment on the matter.

Further order is passed to the effect that the respective Inspector-in-charge/Officer-in-charge of the police stations shall deposit the arms of the licensee in the armory of the police stations under a proper acknowledgement to the licensee and would return the arms to the licensee immediately after **15.05.2018**. They are also directed to serve the notices to all the licensed arms holders of the district within **20.04.2018** without fail. List of such arms, if any, remaining to be deposited with the police stations shall be sent to the Judicial Munshikhana Section of the office of the District Magistrate, Dakshin Dinajpur immediately after **20.04.2018** for appropriate action for defaulting to deposit the licensed arms.


