01. Sound working knowledge in computer.


Essential Qualification for Group-"D":-

01. They should be retired Govt. employee/ Staff of Govt./ Govt. aided School/Madrasah.
02. Minimum qualification should be Class-VIII passed.
03. Upper age limit is restricted upto 64 years as on 01.01.15,

For all the above category remuneration will be last pay during retirement minus pension amount.
