TENDER NOTICE FOR MATERIALS SUPPLY

Sealed tenders are hereby invited by the under signed from the resourceful ,bonafied ,reputed and experienced contractors , Registered Co Operative Societies formed by the Unemployed Engineers or by the Labourers having bonafied Credential in Supply Work in Similar type of work for implementation of the following works under MGNREGS Fund. Details of the tendered Materials Cost to be supplied are given in the **Annexure - A**.

**The tenders have to abide by the following terms & conditions:**

- (1) Last date & time for receipt application- **07.03.2017 upto 3.00 pm**. Last date of sale of tender form- **10.03.2017 upto 3.00 pm**. Tenders papers will have to be sent by Registered Post or Courier Service and by hand and it should reach at the office of the No.4 Boaldar Gram Panchayat or also may be dropped in the Tender Box kept in the office chamber by hand( in sealed cover ) within the period **14.03.2017 to 15.03.2017 up to 2.00 p.m.** The paper reached /dropped after the scheduled time & date and any change in the tender papers after opening of the tender will be out rightly rejected. The undersigned will not be responsible for loss of tenders papers or for the delay in the postal transit. It will be opened on **15.03.2017 at 2:30 p.m.** in the office of the Gram Panchayat. The intending participated tenderer only may remain present at the time of opening tenders papers. 50% Credential in similar type of nature of supply work during last three years along with valid Income Tax, Professional Tax and VAT clearance certificate are required.
- (2) Earnest Money as stated in annexure will have to be deposited by cash and Tender paper Participation fee (nonrefundable) as stated in annexure will have to be deposited separately by Cash **in favour of Proddhan , Boaldar Gram Panchayat**. And Misc. receipt (Form-5) to be collected and to be enclosed with the Tender papers in Original. Tenderers must quote their rates on their own letter headed pad by putting signature & rubber stamp seal . They have to produce all original relevant papers as and when asked.
- (3) Co-Operative Societies(Labour/ Unemployed Engineers) have to submit the attested photocopy of the valid clearance certificate issued by the A.R.C.S. The original have to be produced as and when asked. No special preference regarding price or purchase ,will be accorded to any bidder, state owned enterprises, small scale enterprises or enterprises .
- (4) Sealed Cover must be submitted for the entire Project quoting the Sl. No.& Names of the Project separately on such cover. The rate must be quoted in **less percentage basis** against Tendered Amount both in figures and words. Conditional rate will not be accepted. Any rate above the Scheduled Rate will not be entertained. All rates shall be inclusive of all charges .  
Before submission of the tender, the tenderers must visit the site of project to judge the local condition from all corners and no plea / complain about the site will be entertained afterwards. It will be presumed that the agency offered the tender after reviewing entire position of the project site and the ground realities.
- (5) No claim from tenderers will be entertained for any increase of market price.  
The Tender procedure reserves the right to cancel any or all the tenders without assigning any reason subject to the decision of the Artho - O- Porikalpana Upa Samity
- (6) Incomplete tender will summarily be rejected.
- (7) Time and quality are the essence of the contract. The successful tenderers must supply the materials within the time specified in the "ANNEXURE" for completion of the project in time. No extension of time will be allowed except in cases of natural calamities. If any tenderer fails to complete the supply work within the stipulated time the undersigned will forfeit the earnest money .Apart from that the undersigned may proceed to take penal measure against such tenderer including Black listing also.
- (8) The successful Tenderer will have to start the supply work within **07(seven)** days from the date of issue of supply order otherwise the supply order will be cancelled .No excuse in this regard will be entertained .
- (9) VAT/IT / Cess etc.at the prescribed rates will be deducted at source .

- (10) Before starting the supply work the Tenderers will have to contact with the concerned G.P. Authority. Without the certificate from Nirman Sahayak about quality and quantity of the materials supplied , the payment of bill will not be made.
- (11) Acceptance of the Lowest Tender is not obligatory. The undersigned reserves the right to accept or reject any or all the Tenders without assigning any reason subject to the decision of the Artho – O-Porikalpana Upa Samity.
