The pre-qualification documents alone will be opened at **12.00 Hours on 13.01.2017**, by the Block Development Officer Kumarganj Development Block, chamber where participating bidders may remain present. The financial bid document of the technically qualified bidders will be opened for evaluation and selection of qualified bidders at **12.00 Hours on 17.01.2017**, and the other bid documents will be unopened. If the dates are changed due to un-avoidable circumstances intimation will be given in website and office notice board. No individual intimation will be issued in this connection

Eligibility Criteria for Participation in tender & Information to Bidders.

1. i) The intending tenders should produce credentials of similar nature of **Supply Work completed the minimum value of 25% of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice: or**
 - ii). The intending tenders should produce credentials of 2(two) similar nature of **Supply Work completed the each of the minimum value of 15% of the estimated amount put to tender prior to the date of issue of the tender notice: or**
 - iii) The intending tenders should produce credentials of 1(one) single running work of) similar nature of **Supply Work , which has been completed to the extent of 60% or more and value of which is not less than the desired value of above.**
1. In case of running works only, those tenderer who will submit the certificate of satisfactory running works from the concerned Executive Engineer or Equivalent competent Authority will be eligible for the tender. In the required certificate it should be clearly stated that the work in progress satisfactorily and also that no penal action has been initiated against the executed agency i.e. the tenderer Self attested copies of Pan card, Professional Tax Clearance Certificate, upto date IT Return(Saral), VAT Registration Certificate and upto date return must be up loaded in appropriate folder. Registered Co- Registered Operative Society must upload the Bye-Laws, and other papers and submit the same will full address of their authorized persons to sign the tender documents along with technical Bid papers. During scrutiny of Technical Bid/Tender documents if it is found that any information is incorrect the technical bid/tender documents will be rejected without assigning any reason thereof. The Tender Committee of Kumarganj Development Block will have sole discretion to decide the eligibility of ,the Contractors on the basis of his submitted documents and evaluation and reserves the right to refuse any explanation to the Supplier without assigning any reason thereof and the decision of the Block Authority will be final in this respect. All papers will be verified with original papers as when required.
2. Intending bidders have to submit their bid on-line through e-procurement(two cover system) portal of Kumarganj Block of P & RD Deptt.'s website www.wbprd.nic.in The participation charge and the earnest money should be deposited in the form of Bank draft, preferably Allahabad Bank at Mohana or united Bank of India at kumarganj in favour of Executive Officer.
3. The intending bidders must produce the original documents for scrutiny 16.01.2017 at 12.00hr to 16.00 and submit for earnest money& participation charge Original Draft, as per mentioned date and time to the office of the Block Development officer through e-Procurement system (in the chamber of Block Development officer Kumarganj or by authorized representative).


4. Bids from joint venture are not allowed.
5. The indenting bidders should know the fact that the rates in the tender Notice are **inclusive** all duties, taxes, toll, taxes and other levies payable by the Supplier under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder.
6. No separate claim on any circumstances will be allowed.
7. In this tender no arbitration will be allowed.
8. All the related documents are to be produced **IN ORIGINAL** to this office as and when asked for.
9. No Mobilization/Secured advance will be allowed to selected agency.
10. Its surrounding and obtain all information that may be necessary for preparing the bid and entering into a contract for the work mentioned in the Notice.
11. The Block Development Officer, & Executive Officer, Kumarganj Development Block, authority reserves the right to reject any or whole tender without assigning any reason thereof.

Terms and Conditions:

1. All the Intending Tenderers are requested to Supply the above
2. This Notice Inviting Tender will be treated as a part of the Tender Document.
3. In case of any day, meant for this tender, appears to be an unscheduled holiday, the next working day will be treated as scheduled / prescribed day for the same purpose.
4. No preconditioned tender will be accepted.
5. All the rates of works are inclusive of all taxes, transportation, loading, unloading, stacking, etc including all other incidental charges therein.
6. **The Successful Tenderer, herein after called the Supplier, will have to execute an agreement on a Non Judicial Stamp worth Rs. 100/- only.**
7. Necessary deduction towards VAT, Income Tax and will be made as per Govt. norms, and Security Deposit @ 8% and 10% of the value of supply work will be deducted from each progressive Bill as the case may be. The Earnest Money will be converted into the Security Deposit.
8. The successful Supplier shall have to submit 3 (three) copies of application in the prescribed form for license (Form No VI) duly filled and signed by the contractor along with the tender. The license fee in terms of Rule - 26(2) and the Security Deposit of Labour in terms of Rule - 24 of West Bengal Contract & Labour (Regulation & Abolition) Act, 1972 should be separately deposited to the Local Treasury under the Head of Account - : 843 Civil Deposit - Deposit under various central and State Acts deposit under the contract Labour (Regulation and Abolition) Act, 1970.
9. Sub-allotment of work under any circumstances will not be permitted.
10. Any bill (running account/final) payment of proposed executed work may be made to Agency as per availability of fund.
11. For exemption of the initial earnest money the registered cooperative should submit the registration certificate, By Law of their cooperative from competent authority with Technical bid. Page-2
12. Escalation claimed by the Agency will not be entertained by the Authority.
13. If it is found (after proper verification) by the Block authority that any or more of the documents mentioned above in sl no10 uploaded by any bidder along with tender is a forged or tempered one ,then Block authority will impose penal action against that Bidder as per IT ACT,
