The L1 bidder will be asked for produce the original Trade License before issuance of Work Order. If the L1 Bidder fails to produce the Trade License, the L2 bidder will be given the opportunity and so on.
3. Minimum four numbers of Quotations from different agency must be dropped/submitted. Otherwise the Quotation will be treated as Cancelled on account of lack of Quorum.
