Tender must quote their rate on their pad in figures along with participation charge non refundable in Cash (Misc. receipt) & Earnest money Mentioned in above must be submitted separately by bank Draft/by Cheque / by govt. bond/ securities duly pledged in favour of the Prodhan No. 1 Hili Gram Panchayat.
3. Contractor/ Agency must be submit the attested copy of valid VAT registration certificate, latest income Tax Return, Professional Tax Registration certificate , PAN CARD issued by the Income Tax Department , Trade Registration Certificate / License from local bodies as the case may be, and other related papers must be submitted with the rate quoted papers.
4. Contractor/ Agency must be quote their rate in Percentage (both in figures and words) against the schedule rate putting signature & seal.
5. Contractor/Agency must submit not less than 40% supplying of materials Credential of similar nature of work.
6. Time and quality essence of the contact. The successful suppliers must complete the work within the time specified for completion. No. extension of time will be allowed expect in special cases of natural calamity. If any contractors fails to complete the work / with be enforced on concerned Agency / Contractor. The fine will be recovered from the unpaid Bills.

7. Incomplete Tender will summarily be rejected.
8. All supply will have to be done according to the specification approved by the authority.
9. No consumable materials will be supplied to the Agency for proper execution of the undersigned. The Agency will be responsible for procuring all materials required for proper execution of work at his own cost.
10. All rates shall be enclosed of all charges, royalty toll charge, carriage etc. relevant document of royalty must be produced along with the bill.
11. The successful Tenderer will have to supply the item within 7(Seven) days from the date of issue of work order otherwise the work will be cancelled. No excuse in this regard will be entertained.
12. Acceptance of the lowest Tender is not obligatory and the undersigned reserved the right to accept or reject by or all the Tender without assigning any reason.
13. Any rate above the schedule rate of work will not be entertained.
