The running account bill for the work shall not be treated as claim.

The security money @ 10% including earnest money in case of execution of work will be deducted from the bill amount, which will be released after 6(Six) months from date of completion of the work.

If any defect is found in work during security period, the agency will be held responsible to rectify the same at his own cost, if fails to do the same, the rectification will be made departmentally the cost thereof will be deducted from the security deposit against the work.

Time is the essence of contract. The successful contractor must complete the work within the time specified for completion.

The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum.

In case of failure to start the execution of the work within 15 days, the earnest money will be forfeited.

Any addition or alteration on the scheme may be done as per decision of the authority.

No time will be allowed except in special case.


Successful tenderers will have to enter into agreement in the form of in non-judicial stamp paper of appropriate value duly signed.
