The pre-qualification documents alone will be opened at 12.00 Hours on 29.05.2017, by the Block Development Officer Kumarganj Development Block, chamber where participating bidders may remain present.

The financial bid document of the technically qualified bidders will be opened for evaluation and selection of qualified bidders at 12.00 Hours on 31.05.2017, and the other bid documents will be unopened. If the dates are changed due to un-avoidable circumstances intimation will be given in website and office notice board. No individual intimation will be issued in this connection

Eligibility Criteria for Participation in tender & Information to Bidders.

- The intending bidders should have successfully completed at least one contract of **similar nature of work, at least of 40% value** of the proposed contract within last 5 years from the date of publication of the notice. Such work executed should be in the Government Sector, Zilla Parishad, Panchayat Samiti, Gram Panchayat or Public Sector undertaking. The completion certificate and payment certificate issued by competent authority will be considered as credential in this respect.
- Self attested copies of Pan card, Professional Tax Clearance Certificate, upto date IT Return(Saral), VAT Registration Certificate and upto date return must be up loaded in appropriate folder. Registered Engineering Co-Operative Society and Registered Labour Co-Operatives must upload the Bye-Laws, and other papers and submit the same with full address of their authorized persons to sign the tender documents along with technical Bid papers. During scrutiny of Technical Bid/Tender documents if it is found that any information is incorrect the technical bid/tender documents will be rejected without assigning any reason thereof. The Tender Committee of Kumarganj Development Block will have sole discretion to decide the eligibility of ,the Contractors on the basis of his submitted documents and evaluation and reserves the right to refuse any explanation to the Contractor without assigning any reason thereof and the decision of the Block Authority will be final in this respect. All papers will be verified with original papers as when required.
- Intending bidders have to submit their bid on-line through e-procurement(two cover system) portal of Kumarganj Block of P & RD Deptt.**'s website www.wbprd.nic.in **The participation charge and the earnest money should be deposited in favour of Executive Officer/BDO Kumarganj Block A/C No .34019176846 SBI Patiram IFSC code SBIN0012411.**
- Bids from joint venture are not allowed.
- The indenting bidders should know the fact 'that the rates in the BOQs are **inclusive** all duties, taxes, royalties, cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act.**

1996 will be deducted from the running bills. No. separate claim on any circumstances will be allowed.

6. In this tender no arbitration will be allowed.
7. The intending Tenderers should furnish a list of works executed by them / him / her of similar nature and magnitude as mentioned above with necessary certificate from the concerned Executive Engineer or an Engineer of any Government / Government undertaking regarding satisfactory performance of such works/Block development officer & Executive officer /chairman as the case may be under whom the work has been executed to be submitted at the time of receiving tender. In absence of the above details tender may not be accepted.
8. All the related documents are to be produced **IN ORIGINAL** to this office as and when asked for.
9. No Mobilization/Secured advance will be allowed to selected agency.
10. Running payment for work will be made to the agency by the Block Development Officer,& Executive Officer Kumarganj Development Block, as the case may be as per availability of fund and as per norms.
11. The intending bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 05(five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. Declaration in this respect has to be furnished by the intending bidders in the form of affidavit without which the bid will be treated as non-responsible.
12. The bidders at their own responsibility and risk is encouraged to visit and examine the site of works and its surrounding and obtain all information that may be necessary for preparing the bid and entering into a contract for the work mentioned in the Notice. The cost of visiting the site shall be at the bidder own expense.
13. The Block Development Officer,& Executive Officer,Kumarganj Development Block, authority reserves the right to reject any or whole tender without assigning any reason thereof.

Terms and Conditions:

1. All the Intending Tenderers are requested to visit the sites of works prior to submission of the Tender at their own effort and interest.
2. This Notice Inviting Tender will be treated as a part of the Tender Document.
3. In case of any day, meant for this tender, appears to be an unscheduled holiday, the next working day will be treated as scheduled / prescribed day for the same purpose.
4. No materials, Tools & Plants etc. will be issued by Kumarganj Development Block.
5. No preconditioned tender will be accepted.
6. All the rates of works are inclusive of all taxes, cess, levy, octroi, royalty, transportation, loading, unloading, stacking, etc including all other incidental charges therein.
7. The Successful Tenderer, herein after called the Contractor, will have to execute an agreement on a Non Judicial Stamp worth Rs. 10/- only.
8. Necessary deduction towards VAT, Income Tax and Welfare Cess etc. will be made as per Govt. norms, and Security Deposit @ 8% and 10% of the value of work will be deducted from each progressive Bill as the case may be. The Earnest Money will be converted into the Security Deposit.
9. The successful contractor shall have to submit 3 (three) copies of application in the prescribed form for license (Form No VI) duly filled and signed by the contractor along with the tender. The license fee in terms of Rule - 26(2) and the Security Deposit of Labour in terms of Rule - 24 of West Bengal Contract & Labour (Regulation & Abolition) Act, 1972 should be separately deposited to the Local Treasury under the Head of Account - : 843 Civil Deposit - Deposit under various central and State Acts deposit under the contract Labour (Regulation and Abolition) Act, 1970.
10. Sub-allotment of work under any circumstances will not be permitted.
11. Any bill (running account/final) payment of proposed executed work may be made to Agency as per availability of fund.
12. For exemption of the initial earnest money the registered co-operative should submit the registration certificate, By Law of their cooperative from competent authority with Technical bid.

13. calation claimed by the Agency will not be entertained by the Authority.
14. If it is found (after proper verification) by the Block authority that any or more of the documents mentioned above in sl no10 uploaded by any bidder along with tender is a forged or tempered one ,then Block authority will impose penal action against that Bidder as per IT ACT,
