If the dates are changed due to un-avoidable circumstances action will be given in website and office notice board. No individual intimation will be in this connection.

Eligibility Criteria for Participation in tender & Information to Bidders.

1. Self Attested copies of valid Income Tax, (Pan Card), Sale Tax/VAT, Professional Tax Certificate must be up loaded in appropriate folder. Registered engineering Co-Operative Society and Registered Labour Co-Operatives must upload the Bye-Laws and other papers and submit the same with full address of their authorized persons to sign the tender documents along with technical Bid papers. During scrutiny of Technical Bid/Tender documents if it is found that any information is incorrect the technical bid tender documents will be rejected without assigning any reason thereof 1st tender Committee of Gokarna Gram Panchayat, Harirampur will have sole discretion to decide the eligibility of the Contractors on the basis of his submitted documents and evaluation and reserves the right to refuse any explanation to the Contractor without assigning any reason thereof and the decision of the Pradhan, Gokarna Gram Panchayat, Authority will be final in this respect. All papers will be verified with original papers as when required.
