Failure to submit the hard copy of EMD with the acceptance letter within the time period prescribed for the purpose may be construed as an attempt to disturb the tendering process and dealt with accordingly legally including black listing of the bidder.

The suppliers will have to deposit EARNEST MONEY @ 2% of the quoted / tendered amount in form of Banker's Cheque/Bank Draft in favour of the Prodhhan, Binshira Gram Panchayat Payable at Bangiya Gramin Vikash Bank, Teor Branch which have to be upload to the appropriate folder positively failing which the Quotation / Tender will be rejected.
7. Incomplete Quotation/ Tender will be summarily rejected.
8. Acceptance of lowest quotation/tender is not obligatory and the undersigned reserves the right to accept or reject any or all the Quotations/Tenders without assigning any reason whatsoever.
9. The undersigned also reserves the right to distribute the Supply Order among as many Suppliers as may be considered.
10. Cost of Tender Document (tender fee) is Rs.750.00 for SL.No.-1 which will be deposit by CASH/RTGS/NEFT only to the Bangiya Gramin Vikash Bank, Account No.- 5539010000466, Teor Branch, IFSC Code- UTBIORBBGB, Teor Branch in favour of Prodhhan Binshira Gram Panchayat. 17. Successful Tenderers (hereinafter may be called as the Contractor/Supplier) should have to execute an Agreement with Binshira G.P. as per norms and should submit work programme accordingly.

Qualification Criteria:-

The Tender Inviting & Accepting Authority will determine the eligibility of each bidder, the bidders shall have to meet all the minimum criteria regarding:-

a) Technical Capability comprising of personnel & equipment capability

The eligibility of a bidder will be ascertained on the basis of the attested documents in support of the minimum criteria as mentioned "a" above and the declaration executed through a **non-judicial stamp paper** of appropriate value worth Rs. 10.00 (Ten) duly self-signed. If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder/tenderer will be out rightly rejected at any state without any prejudice with forfeiture of earnest money forthwith.

The Prodhhan, Binshira Panchayat reserves the right to reject or cancel any or all pre-qualification documents and tender documents without assigning any reason whatsoever.
