Manufacturers/Authorized Dealers are requested to quote their rates both in figure and words per MT/Kg for Steel and Cement per Bag including cost of steel & Cement, carrying, loading, unloading, stacking at Municipal stack yard or working site i.e. as par direction of the undersigned etc complete. The rate should be inclusive of all taxes like custom duty, sale tax, VAT etc complete for the year 2017-18. The quotation will be received by this office on or before 03-04-17 upto 3-00 P.M through the posts or courier or by person in receive section and will be open on the same date at 3-30 P.M. in presence of quotqtioners or Authorized representative.

Quotation shall be considered on the basis of following conditions:-

1. Test certificate shall be produced confirming brand with ISI mark at the time of supply.
2. Mode of payment shall be mentioned properly.
3. Road challan along with the gate pass of the concerned producer shall be produced at the time of supply.
4. Every bundles of the steel should be tied with "Logo" of the brand with the steel and also be embedded the Logo on every piece of steel.
5. The length of each rod should not be less than 12.00m.
6. The minimum period of validity of rates not less then 6 (six) months since acceptance.
7. Quotationers will submit their quotation super scribing on the envelop "Quotation for supply of steel/Cement for Municipal development work.
8. Fixed Earnest money of Rs 25000/- (Rupees twenty five thousand ) only to be deposited in the form of D.C.R, or A/C payee Bank Draft in favours of Balurghat Municipality along with Quotations
