**SCRAP AUCTION NOTICE**

Sealed Bids on plain paper are invited for auction for unserviceable old Tube well scrap materials (Tubewell spare parts) at No. 10 Malancha Gram Panchayat Godown.

Auction Bid will be received upto 2 pm on 21/03/2017 and will be opened on the same date at 2.30 pm in presence of bidder.

N.B. – If the office remains closed in any unavoidable circumstances on above-mentioned any days, then next working day will come into force & the scheduled time will remain unchanged.

Artho O Parikalpana Upasamity has been decided a minimum auction rate per kg i.e., Rs.13.00/kg as per judging the local market price.

The bidder have to quote the rate per kg. only above the rate fixed by the authority at plain paper and to deposit on Rs.5000.00/- (Rupees five thousand only) in cash as Security only at the time of submission of bid. The same will be refunded to the unsuccessful bidders.

All the junk dealers may participate in the auction. The condemned items will be sold to the highest bidder. If the highest bidder denies to purchase scrap materials his security deposit will be forfeited. After completion of bid the highest successful bidder will must deposit the total amount of the bid to the office of the undersigned on the same date within 5pm. No concession will be given on this account from the authority.

The authority reserved the right to accept or reject any rate without assigning any reason thereof. The intending bidders are requested to inspect the materials to be Auctioned before submission of bid to be well acquainted with the quality and quantity of scrap materials.

Bidders must quote rates in absolute numerical values (both in figures and words) Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.

Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.

Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.

Any bid received from the bidder without authentication of correction made in rate quoted in word or figure shall lead to cancellation of the bid.
