
(i) 3 (three years maintenance cost will be borne by the Agency

Next 30% of the security money will be refunded to the Agency after 2 (two) years from the date of completion of the work and rest 40 % of the security money will be refunded to the Agency after 3 (three) years from the date of completion of the work.
