Sealed Quotations are hereby invited by the undersigned from eligible Agency/Firm/Owner in their own papers within next 07 (seven) days from the date of issue of this Quotation Notice for hiring one good conditioned Car at a daily rate basis for an initial period of 06 (six) months. The period may be extended as well as renewed further on the basis of the current performance of the Car and the availability of " **FUND FOR MOBILITY SUPPORT OF BPMU** ".

NECESSARY CRITERION:

1. Only sealed quotations addressing to the undersigned will be accepted by registered/speed post/ courier/manual dropping at the office of the undersigned.
2. The Car must be holding a valid Registration as Commercial Car conforming Bharat stage-III/IV and Diesel driven-Non AC type.
3. The Car should be in good and sound condition having Road Permit, Tax Clearance and all other related documents required for plying in the roads.
4. The bidder must have PAN, Service Tax Registration and Commercial Tax Registration of current validity.
5. The driver of the Car should possess the commercial driving license issued by the RTO or appropriate authority.
6. No additional payment outside accepted rate is payable for hiring of driver (s) and/or for boarding & lodging of driver (s)/or cost for repair etc arising due to accident met by the vehicle, if any.
7. In case of any temporary withholding of service of the vehicle for repair/maintenance/illness of the driver etc by the vehicle owner, substitute vehicle of same quality and/or, alternate driver is to be provided for the period of withholding subject with prior intimation to authority concerned.
8. Reimbursement of POL consumed by the vehicle @ 1 (One) litre HSD for 12 KMs and 1 (One) litre Mobil for 500 KMs will be made separately to the owner as per existing Govt. norms only.
9. For the vehicle, the driver has to maintain one positive log book where every details of the car movement should have to be entered for each and every journey and all the entries mandatorily have to be countersigned by the undersigned.
10. The bidder should be bound to provide the Car as a daily rate basis as per requirement by the undersigned.
11. The daily rate is for 10 hours a day and additional charges @ Rs. 20.00 per hour beyond 10 hours.
12. The payment will be disbursed on monthly basis as per availability of the existing fund.
