The counter foil (subscribing the NIT No. and SL No. and duly signed by the contractor/his representative over it) of participation charge or earnest money as the case may be must be submitted at the time of Tender dropping.

3. Without Photo copy of Participation Charge and EMD the bid will be treated as non-responsive.
4. The application for issuing Tender Documents of the prospective bidder will be considered only if the bidder found qualified according to the minimum qualification criteria as mentioned in this NIT by the "Tender Committee" formed by Dakshin Dinajpur Zilla Parishad and the decision of the Authority.
5. The bidder shall submit all the technical papers, credential Certificate, Photo copy of Earnest Money, Participation Charge receipt etc. in cover-1 Subscribing " Technical Bid".
The 2nd cover will contain the % Offered rate in the form of % below/above/at PAR. The 2nd cover will be subscribed as " Financial Bid".

Eligibility Criteria for Participation in tender & Information to Bidders.


1. The intending tenderers should have successfully completed at least one contract of **Similar nature of work, at least of 40% value** of the proposed contract within last 5 years from the date of publication of the notice. Such work executed should be in the Government Sector, Zilla Parishad, Panchayat Samiti, Gram Panchayat or Public Sector undertaking. The completion certificate and payment certificate issued by competent authority will be considered as credential in this respect.

2. PAN Card, Professional Tax Clearance Certificate, VAT Registration Certificate if necessary to be accompanied with Tender documents.
3. The prospective tenderers or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such **abandonment or rescission** will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders without which the Bid shall be treated non-responsive).
4. Registered Unemployed Engineers' Co-Operative Societies are required to furnish valid Bye Law, Current Audit Report.
5. Running payment for work may be made to the executing agency by FC & CAO, DDZP / Additional Executive Officer, DDZP / Executive Officer, DDZP as the case may be as per availability of fund and as per norms.
6. **Constructional Labour Welfare Cess @ 1 (one) %** of cost of construction and other deduction will be deducted from every Bill as per Govt. norms.
7. In connection with these works, **no arbitration** will be allowed.
8. **No mobilization/secured** advance will be allowed.
9. **No Price Preference** will be allowed.
10. The Tenderer's at his own responsibility and risk is to visit and examine the site of work and its surrounding examine and the schedule of work, rates etc. and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, the cost of visiting the site shall be at the Bidder's own expense.
11. Prospective applicants are advised to note carefully the **minimum qualification criteria** as mentioned in the Tender Notice before tendering the bids.
12. **Attested copy of License for Electrical Contractor should be valid upto date of tender.**
