2. Indenting tenderers should submit application within specified time along with self-attested copies of specified documents as indicated / listed in the eligibility criteria in this NIT. The Specified Schedule will be available in the Establishment Section of the office of Sub Divisional Officer,Gangarampur at Buniadpur,Dakshin Dinajpur, , during office hours and will be supplied to the intending Tenderers free of cost.

3.The earnest money should be deposited through Bank Draft in favour of the Sub Divisional Officer,Gangarampur at Buniadpur,Dakshin Dinajpur and Participation Charge may be deposited through savings account No. **11889406871** (SBI, Buniadpur) in favour of the Sub Divisional Officer,Gangarampur at Buniadpur,Dakshin Dinajpur. The scanned colour copy of counter foil (subscribing the NIT No. and SL No. and duly signed by the contractor/his representative over it) of participation charge and earnest money must be submitted at the time of tender dropping.

4.Bank solvency certificate (100% of the estimated value of tender).

5.Without Photo copy or Scanned Copy of Participation Charge and EMD the bid will be treated as non-responsive.

6.The application for issuing Tender Documents of the prospective bidder will be considered only if the bidder found qualified according to the minimum qualification criteria as mentioned in this NIT by the “Tender Committee” formed by the Sub Divisional Officer, Gangarampur at Buniadpur,Dakshin Dinajpur and the decision of the Authority.

7.The bidder shall submit all the technical papers, credential Certificate, Photo copy of Earnest Money, Participation Charge receipt etc. in **cover-1** Subscribing “ Technical Bid”.

The 2nd cover will contain the % (Percentage) Offered rate in the form of %(Percentage) below/above/at PAR. The 2nd cover will be subscribed as “ Financial Bid”.

8.Eligibility criteria for participation in tender :-

i) The prospective tenderers shall have satisfactory completed during the last 5 (five) years from the date of issue of this Notice at least **one similar type of work** in the Govt. sector, Zilla Parishad, Panchayat Samity, Block or Gram Panchayat or Public sector /undertaking and having a **magnitude of 60 (sixty) percent of the amount put to tender**. Only completion certificate and also payment certificate of the work will be considered as credential in this respect.

ii) PAN Card, Professional Tax Clearance Certificate, IT return (Sara),GST Registration Certificate, Trade Certificate to be accompanied with Tender documents.

iii) The prospective tenderers or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders without which the Bid shall be treated non-responsive).

iv) Registered Unemployed Engineers’ Co-Operative Societies are required to furnish valid Bye Law, Current Audit Report.

9. Running payment for work may be made to the executing agency by the Sub Divisional Officer, Gangarampur at Buniadpur, Dakshin Dinajpur as the case may be as per availability of fund and as per norms.
10. Constructional Labour Welfare Cess @ 1 (one) % of cost of construction and other deduction will be deducted from every Bill as per Govt. norms. The earnest money deposited by you should be treated as part of security deposit and rest amount should be deducted from your bill for consist of 10% amount of security deposit. Such security deposit (only for work contract) should be refunded to you after 6 (Six) Months from the date of satisfactory completion of the work.
11. In connection with these works, no arbitration will be allowed.
12. No mobilization/secured advance will be allowed.
13. No Price Preference will be allowed.
14. The Tenderer's at his own responsibility and risk is to visit and examine the site of work and its surrounding examine and the schedule of work, rates etc. and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, the cost of visiting the site shall be at the Bidder's own expense.
15. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in the Tender Notice before tendering the bids.
16. If the tender opening day happens to be a holiday in that case the tender will be opened on next working day at the same time.
