**PUBLIC NOTICE**

***"Under Section 3G(1), 3G(2), 3G(3), 3G(4) of N.H. Act, 1956 (48 of 1956)"***

In exercise of powers under Section 3D(1) and 3D(2) of the National Highways Act, 1956 (48 of 1956) the schedule hereunder have vested absolutely in the Central Government free from all encumbrances by publication of Notification of acquisition in the Gazette of India (Extra-ordinary) bearing No. S.O. 886 (E) dated 28/02/2018 for "Up-gradation of NH-512 with a minimum of 2-Lane with paved shoulder configuration starting from Ch. 82.400 k.m. to 99.500 km and minimum of 4-Lane with Truck lay-by configuration from Ch. 104.200 km to Ch. 107.100 km in the District of Dakshin Dinajpur, West Bengal" and under the provision of Section 3G(1), 3G(2), 3G(3) & 3G(4) of the National Highways Act, 1956 (48 of 1956), it is hereby informed to the land owners and all interested person whose lands were acquired U/S-3D(1) and 3D(2) of the National Highways Act, 1956 for "Up-gradation of NH-512 with a minimum of 2-Lane with paved shoulder configuration starting from Ch. 82.400 k.m. to 99.500 km and minimum of 4-Lane with Truck lay-by configuration from Ch. 104.200 km to Ch. 107.100 km in the District of Dakshin Dinajpur, West Bengal" may appear and submit their claims along with the copies of all relevant documents i.e. i) Self Identification, ii) Sale Deed, Bantanama & other Deed relating to Title, iii) L.R.
