

1. The Bidder should apply for Tender in their own Pad along with current valid PAN issued by the IT Deptt. Govt. Of India valid 15-digit Good and IT up to date Tax paper identification number (GSTIN) under GST Act, 2017 and with similar nature of credential certificate in the form of completion certificate of amounting Rs. 2Lakhs 36 Thousand.
2. Application for Quotation in their own letter head along with necessary documents must be submitted by the contractors himself or owner in case of construction firm. In case of Registered Co-Operative societies formed by the unemployed Engineers / Labours, application must be submitted by the Chairman / Secretary. The co-operative must submit audit report of the firm for last three years.
3. Application with relevant documents will have to be dropped in the Quotation Box kept in the chamber of the undersigned within the specified dated time positively. No extra time will be entertained. If the date of dropping and opening of tender is declared to be holiday the tender will be dropped and opened on the next working day in the schedule date and time.

The Executing Agency should abide by the norms mentioned below:-

1. The Executing Agency should strictly follow tender/ e-tender process and any change in the Plan & Estimate if required, should be intimated to the Department of Planning Section, Dakshin Dinajpur Collectorate before execution.
2. The work must be supervised by competent person with adequate qualification (not below DCE).
3. Preparation of Measurement Book duly signed by the SAE-in-Charge, Bill in proper format is mandatory.
4. The Executing Agency must take adequate number of photographs of the work-sites (with display board showing name of the work, fund, financial year, name of the Executing Agency, Amount) before commencement, during and after completion of the work & should send the authenticated copies with the physical & financial progress report in prescribed format. The work should be completed within 5 (six) month of receipt of this order.
5. A signboard/ plaque carrying inscription "MPLADS WORK" along with the name of M.P. at the site shall be erected permanently and prominently.
6. The interest accrued on the funds released under the MPLADS scheme to the implementing Agencies shall be calculated as per guideline. The savings for each work must be refunded to the District Authorities within 30 days of the completion of the work.
7. If the estimated cost is higher than the sanctioned amount, the Executing Agency will be responsible for excess payment as no fund beyond sanctioned amount will be allowed.
8. After completion of the said scheme the implementing Agency should hand over the scheme to the respective GP/Municipality/School Authority/ NGO etc.
