Terms & Conditions:-

- The Tender Fee/EMD should be deposited through RTGS/NEFT in the Savings bank Account of Prodhan, No. 5 Bhatpara Gram Panchayat bearing no. 1977010015978, IFSC - UTBIOBHQW81, maintained at United Bank of India, Bhushila Branch and the deposit document must be entered in the online portal. The scanned copy of counter foil (super scribing the NIT No. and Sl. No. duly signed by the bidder) of earnest money or Tender Fee as the case may be, must be uploaded in the appropriate folder of online portal.**
- Bidders must submit self attested photocopies of valid Trade License from local bodies, GSTIN registration, PAN, latest Income Tax Return and Profession Tax Clearance Certificate with current challan as the case may be. Registered Unemployed Engineers' Co-operative Societies/ Unemployed Labour Co.- Op. Societies are required to furnish valid Bye Law, Current Audit Report, Valid Clearance Certificate from A.R.C.S. for the year 2018-2019. The partnership firm is required to furnish copy of Registered Partnership Deed. A Company shall furnish the Article of Association and Memorandum.**
- Bidders must submit self attested photocopies of Work Order, Completion Certificate and Payment Certificate / Credential Certificate in similar nature of work during last 3 years from the date of issue of notice for proofing credential submitted as previous.**
- In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- Bidders must quote rates in absolute numerical values (both in figures and words) against the estimated cost in percentage rate basis.
- Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Co-operative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.
- Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Cash/Cheque/Bank Draft/Government Bond / Securities duly pledged in favour of the "Prodhan, No. 5 Bhatpara Gram Panchayat" OR the amount may be deducted from every running payment (not exceeding two including the final bill) made and will be released after 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
- GST, TDS and applicable Cess (if any) will be deducted as per existing rates fixed by the respective department of the Government.
- Bidder must submit sealed envelope clearly mentioning serial number and name of work on top of the envelope.
- Site visit may be done by the bidders at their own cost.
- Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
