- Bidders must submit self attested photocopies in the Technical Bid cover (valid GSTIN Registration Certificate, PAN, Last 3years Income Tax Return (19-20,18-19,17-18), Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be).
- They should also submit self attested photocopies of 60% Payment Certificate/Credential in amount of Tender amount along with Supply order copy of any type of MGNREGS work during last 3 years.
- Bidder must submit sealed envelope clearly mentioning serial number and name of work on top of the envelope.
- Bidders must quote their rates in absolute Percentage basis(%) (both in figures and words)** against the Tender amount **over on his own Letter head pad.**
